Young Burundians encouraged to invest in rabbit farming to promote the country's socioeconomic development



n Tuesday June 6, 2023, the Head of State, His Excellency Evariste Ndayishimiye, granted a donation of rabbits to three Burundian artists in order to encourage them to invest in breeding to contribute to the socio-economic development of the country.

It is through the Chief of State Protocol Col. Jules César Ndihokubwayo that this donation was given to Mr Minani Fleury alias Mutima (Comedian), Mr Vianney Nzigamasabo alias Vichou love (Musician) as well as Mr Boniface alias B. Face (Musician).

In his remarks, Col. Ndihokubwayo indicated that this donation of rabbits and their hutches is a promise made to these three artists by His Excellency the President of the Republic on February 11, 2023 during the celebration of "Inkerebutsi day".

"By offering these rabbits, the Head of State would like young people to take the lead in the field of cuniculture" suggested the Head of State Protocol before adding that the Head of State considers this donation as a capital which must be brought to fruition and serve as a model for other young people.

ixteen magistrates of the Court of Auditors, including the President of this Court, Mrs. Générose Kiyago and 15 Councilors were sworn in before the President of the Republic of Burundi and the Parliament, Monday June 5, 2023 at the Kigobe Congress Center.

his Wednesday June 07, 2023, the First Lady of Burundi HE Angeline NDAYSIHIMIYE received in audience the Consul of Italy in Burundi, Mrs. Catarina lametti. She was accompanied by a delegation of doctors specializing in pediatric surgery from the Italian NGO Emergency represented by Luca Rolla, the Regional Director in charge of the programs.

This audience, which is part of the collaboration between the "Fondation Bonne Action Umugiraneza" and Italy, was preceded by a decent of this delegation at the Polyclinic Umugiraneza located in Kibimba, on June 06, 2023.

As the First Lady indicated, these specialists had come to identify children who have congenital biological malformations, often misunderstood and neglected by Burundians, such as cleft lip and palate, testicular ectopia and inguinal hernia so that they receive appropriate surgical care.

She said that these diseases are treatable and curable when diagnosed in time and that the 15 children diagnosed with these malformations will soon be sent to Uganda, to the Children's Surgery Hospital in Entebbe, to be treated free of charge by these doctors.

"After these treatments, we recommend signing a partnership between the Umugiraneza Foundation and this NGO," she added. This partnership will consist, for example, in building the capacity of Burundian doctors in pediatric surgery so as not to always "depend on others. She pointed out that, in the future, said partnership could extend to the fields of pediatric cardiology and ophthalmology and many others.

HE Angeline NDAYISHIMIYE, on this occasion, launched a special appeal to Burundian parents, especially those who have male children, to go to the Umugiraneza Polyclinic and the Prince Régent Charles Hospital, the two diagnostic centers, s 'they notice abnormalities related to these malformations instead of hiding them at home as some do.

Consul Catarina lametti appreciated the initiatives of the First Lady to "help and support vulnerable people", that is why Italy and Emergency did not hesitate to support her, through the "Fondation Bonne Action Umugiraneza", in view of "saving lives."

The First Lady recalled that the multisectoral relations and cooperation between Burundi and Italy have always been appreciable and that she is delighted that they continue on good terms, taking this opportunity to thank this country for its initiatives towards the Burundian people. The Ministry of East African Community Affairs, Youth, Sports and Culture in collaboration with UNFPA and UNDP organized, in Makamba, from June 6 to 7, 2023, a meeting of youth organizations, the civil society, administrators and representatives of political parties in Makamba, Bururi, Rumonge and Rutana provinces. This activity was part of the development of the national

youth strategy on peace and security (2023-2027).

MEDIA RELEASE N°07 CONSECUTIVE TO THE CABINET MEETING HELD ON WEDNESDAY 07 JUNE 2023

A Cabinet meeting was held in Bujumbura on Wednesday 07th of June 2023, under the chairmanship of His Excellency Major General Evariste NDAYISHIMIYE, President of the Republic of Burundi.

After the presentation and adoption of the agenda, His Excellency the President of the Republic invited the Prime Minister to present the summary of the observations resulting from the preparatory meeting of the Council of Ministers which the Prime Minister chaired on Friday 02 June 2023, and which was devoted to the analysis of the same files on the agenda.

After restitution by the Prime Minister to the President of the Republic, the following issues were analyzed:

1. Draft National Housing Policy, presented by the Minister of Infrastructure, Equipment and Social Housing.

The housing policy dates back a long time. From the colonial era until around 1979, the housing policy consisted of housing state officials free of charge, especially in Bujumbura. The houses were equipped and maintained by the state. Neighborhoods have been subdivided and housing of various standings has been built. This constituted a burden that the State could no longer bear at a certain moment.

From 1979 to 1990, the Government changed its strategy by adopting the formula of transfer of housing to their occupants, granting them a housing allowance equal to 60% of the salary, to enable them to reimburse the cost of acquiring the house.

From 1990, a new policy of assistance for the acquisition of housing by civil servants was put in place. This is how SIP and ECOSAT were created.

From 1990 to the end of 2022, a proliferation of new unserviced neighborhoods has been observed. Thus the frantic race for the acquisition of individual plots has become a speculative trade as the building plots produced by the public services could no longer satisfy the demand.

We had to think of a new strategy.

The proposed new housing policy focuses on the following strategy:

- Make viable land available, favor high-rise constructions as far as possible and on less fertile sites to preserve agricultural areas;
- Favor the hire-purchase system in order to reduce the financial stress of buyers;
- Channel financing through a system sufficiently controlled by the Central Bank to avoid the phenomenon of real estate crisis;
- Clearly distinguish the roles of the different actors, namely: the State, the buyers, the financiers, the construction companies, the network managers, the support services for the management of housing once built;
- Accompany the new policy by setting up the required legal and regulatory framework.

At the end of the analysis, the policy was adopted with the following observations and recommendations:

- Put this policy into practice by launching the first construction sites for these social housing units as soon as possible;
- When implementing this policy, collaborate with REGIDESO so that newly built neighborhoods have sufficient water and electricity;
- Support this policy through the mobilization of investors and reimbursement guarantees via the central bank;
- Ensure that waste and sewage disposal are well managed;

- Extend this policy in all the Provinces (according to the new redistricting) to encourage the population to go and live inside the country;
- Build social housing considering the demands and having ensured the repayment capacity of the beneficiaries;
- Bank deposits intended for investment should be used in this policy;
- Support the City of Bujumbura in waste collection;
- Ensure that the houses given for hire-purchase in certain districts of Ngagara, in particular District VI, have all been reimbursed;
- The Ministry in charge of community development should set up types of villages according to the socio-economic classes of the population.
- 2. Information note concerning the social housing construction project on the KIZINGWE-BIHARA and SOCARTI sites, presented by the Minister of Infrastructure, Equipment and Social Housing.

This social housing construction project was initiated after having observed a frantic race for the acquisition of individual plots for a long time, via a trade that had become very speculative throughout the country, due to the fact that the land to be built granted by the public services could not no longer meet demand. Even households with a relatively high standing are settling in unserviced outlying neighborhoods because of land speculation. The situation is more worrying in the outskirts of the City of Bujumbura and its surroundings, with a serious threat of the disappearance of agricultural areas in the Imbo plain.

The shrinking of agricultural spaces as well as a galloping demography appeal for change of strategy in terms of urban management. The recommended formula is the construction at height as far as possible and in sites less suitable for agriculture.

This Project consists of erecting, on the KIZINGWE-BIHARA Site, after servicing by integration, 5,000 apartments in social housing instead of housing only 600

purchasers of plots. The site has an area of 300ha, 53% going to the owners of the land, while the 47% remaining with the State.

On the SOCARTI Site, 1,600 social housing apartments will be built.

The cost of these accommodations will differ according to the categories of these apartments.

After analysis and debate, the project was adopted with the following comments:

- Given the location of the KIZINGWE-BIHARA site, consider the necessary measures to ensure that water from this site cannot cause flooding and carry away the houses built in the Nyabugete district;
- Given the mentality of Burundians accustomed to living in individual dwellings, it
 will be necessary to sensitize the occupants of the apartments on cleanliness and take
 the necessary support measures.
- 3. Draft school agreement between the State of Burundi and the United Methodist Church in Burundi in the field of education and training, presented by the Minister of National Education and Scientific Research.

Following the many reforms that have taken place in the Burundian education system and enshrined in certain legislative texts as well as the regulatory texts for their application, it has been noted the need to update the partnership agreements in the management of educational institutions and training with religious denominations in accordance with these reforms and the recommendations of the General Symposium of Education.

The process of updating these conventions resulted in the establishment of a standard Church-State convention in Burundi, together with the related application procedures with a view to revitalizing it.

This draft update of the School Agreement between the State of Burundi and the United Methodist Church in Burundi, signed on 04/15/2002, has been prepared, analyzed and accepted by both parties.

It refers to this standard Convention.

This draft convention reaffirms that the United Methodist Church has the right to organize the course of religion / Morals while respecting the right of worship in the establishments entrusted to it. It is also indicated that the establishments under agreement are an integral part of public education and are administered and managed in accordance with the legal and regulatory provisions of public education subject to the provisions of this agreement. The project also indicates the part of the contribution of the United Methodist Church to the efforts of the State in the development of education in terms of material and financial means.

Following the analysis of this file, the project was adopted with, among other recommendations:

- Put a provision that specifies that the school automatically returns to the hands of the State if, after a certain time, the Church fails to fulfill its obligations vis-à-vis this school:
- Introduce a provision indicating that the land granted by the State on which the schools under agreement are erected remains the property of the State;
- Review all the agreements signed in order to ensure that the land granted by the State has been or is being exploited in accordance with the purpose for which it was given;
- Envisage the withdrawal of land granted by the State and which is not exploited, to entrust it to cooperatives;
- Avoid giving title deeds for land granted for exploitation for a social purpose.
- 4. Draft decree on the classification and rating of jobs in the Burundian public administration + Note on the proposals for the implementation of the fair wage policy in institutions with special statutes, presented by the Minister of Public Service, Labor and employment

The National Program for the Reform of the Administration adopted by the Government in 2012 provided, among the actions intended to improve the

management of the public service, the realization of a classification and a rating of the jobs of the Public Administration. These pursue a dual objective, namely:

- Allow a detailed description of said jobs, determine the qualifications they require and the constraints they impose, in order to seek the best possible match of job holders to the missions assigned to them;
- Establish a comparability of all jobs in the Public Administration, in order to ensure fairness in the remuneration of civil servants, executives and agents of the public sector.

This draft decree proposes:

- A definition of job classification;
- A definition of the rules applicable to this classification and this listing;
- Procedures for carrying them out;
- A definition of the effects and consequences of both classification and rating

As for the Note on the implementation of the fair wage policy in institutions with special status, it notes:

- The anarchy in the setting of staff remuneration and the terms of annual advancement;
- The disparities related to the annual rate of advancement;
- The disparities related to the mode of advancement;
- Disparities related to allowances and bonuses.

After discussion and debate, the project was adopted with, among other recommendations:

- Rephrase the title by emphasizing that it concerns public service jobs;
- Avoid repeating in the body of the project the texts already found in the visas;
- Specialized institutions with special status, public establishments and personalized administrations are called upon to implement the salary policy by adopting the new formula "index share and employment share" and submit the file to the competent authority;

- Ensure that the job classification has been done well because it is this that can once again create wage disparities if we are not careful;
- Review the law on the Code of private companies with public participation to bring harmony to companies with public participation and facilitate the implementation of wage policy in these companies. But, a company that wants to adopt the new formula can do so while waiting for this law.
- 5. Draft decree revising Decree No. 100/171 of September 30, 2009 fixing the levels of recruitment and the salary scales of civil servants, presented by the Minister of the Public Service, Labor and Employment.

The General Staff Regulations introduce changes in the management of recruitment and careers of civil servants. However, it was decided not to modify the organization of the index grid and the level of the recruitment levels which are fixed by decree n° 100/171 of September 30, 2009.

However, this decree, even if it organizes the index grid of civil servants, also includes other provisions, which are not compatible with those of the new Statute. This proposed project revises the current decree by:

- Retaining the index grid and the levels of recruitment, but removing the distinction between teachers and non-teachers.
- Removing special provisions applicable to teachers.

After analysis of this draft decree, it was adopted with the following observations and recommendations:

- Use the current nomenclature with regard to the diplomas issued while indicating the equivalences with the old diplomas;
- Check whether this draft decree concerns all categories of civil servants in the public administration;

- Carry out a study on the ratio "Teacher/Students" and "Class/Students" to better see the number of teachers to be recruited.
- 6. Note on the issue of sugar production and marketing at SOSUMO, presented by the Minister of the Environment, Agriculture and Livestock

SOSUMO produces a quantity of sugar each year that fluctuates around twenty thousand tons (20,000). This quantity remains insufficient in relation to local demand because annual sugar needs are estimated at thirty-six thousand tonnes (36,000) and are constantly increasing. In order to meet the local demand for sugar, SOSUMO resorts to imports to supplement its production.

The current sugar price structure dates from March 2017 and no longer allows SOSUMO to cover all expenses given the current economic situation.

Given that the company's main source of revenue comes from the sale of sugar, any upward variation in prices in the acquisition of agricultural inputs, equipment and products involved in the sugar production process has a negative impact on the business life.

Given the current exchange rate, SOSUMO sells sugar at a loss, especially imported sugar, which has a very negative effect on its activities and risks driving the Company to bankruptcy if accompanying measures are not taken in time.

To deal with this delicate situation, two proposals for mitigation measures are made:

- 1° Increase the selling price of a kilo of sugar;
- 2° Defer the collection of taxes paid by SOSUMO.

At the end of the analysis of the Note, the Council of Ministers noted that indeed, the price structure deserves to be reviewed, but recommended the following:

- Redo the calculations by showing the share of locally produced sugar and the shock produced by imported sugar to set a reasonable price structure;

- Show the production cost of a kilo of locally produced sugar;
- Develop a study on the shock produced by the adjustment of the exchange rate to be presented to the partners.

7. Any Other Business

- His Excellency the President of the Republic informed the Council that the farming season was very good. He indicated the measures taken for a good management of the harvest. He asked the Ministers in charge of Trade, Agriculture and the Interior to come together to determine the cost of producing beans in order to set a more profitable producer price.

In this same context, ANAGESSA was asked to constitute a strategic stock of beans.

- His Excellency the President of the Republic has also asked the Minister in charge of Agriculture to review the price of tea by setting a more profitable producer price, like what has been done for coffee.
- He did not fail to remind members of the Government to sensitize the population to irrigate crops during this dry season to fight against hunger, and above all that each household has at least a small plot of land to maintain during this period.
- His Excellency the President of the Republic informed the Council of Ministers that the situation in the country is very good from all points of view, but that it is the legal issues that preoccupy the population. He indicated that strategies are being implemented to provide solutions.
- To close the session, His Excellency the President of the Republic congratulated the Members of the Government because, if Burundi has become a country that can be visited and appreciated today, and that Burundi's partners are reassured by the ways that Burundi has taken, it is thanks to the work of the members of the Government.
