National Assembly: election of the members of the CVR



he National Assembly elected by secret ballot three members of the Truth and Reconciliation Commission CVR during its plenary session of may 30, 2022.

The three commissioners elected are Ambassador Stella Budiriganya (Tutsi), Ambassador Laurent Kavakure (Hutu) and Sheikh Kajandi Sadiki Abdallah (Muslim Hutu).

These three commissioners were chosen from among the 9 who had been selected by the joint committee responsible for the pre-selection of candidate members of the CVR.

Before the vote, each candidate presented his CV and what he intends to contribute to the activities of the CVR.

According to the President of the National Assembly, The Right Honorable Gélase Daniel Ndabirabe, this vote took place because the CVR wanted to replace three of its members, one Tutsi and two Hutu, including one Muslim.

Among the three Tutsi candidates, it was Ambassador Stella Budiriganya who received the most votes, 89 votes out of 120. On the Hutu candidate side, there were six, it was Ambassador Laurent Kavakure who came out on top with 119 votes out of 120. But among the 6 Hutu candidates there were two Muslims, it was Kajandi Sadiki Abdallah who won with 86 out of 120 votes, ahead of Haruna Nkunduwiga. (www.rtnb.bi)

n tuesday, may 31, 2022, the Burundian Senate met in plenary session to analyze the bill on the regulations and budget report for the 2020-2021 financial year. It was the Minister of Finance, Budget and Development Cooperation who represented the Government to present this bill and enlighten senators on its various aspects. In the presentation of the content of this bill, the Minister Domitien Ndihokubwayo indicated that the general budget of the State was stopped at 1576 184 805 156 BIF, while the revenue forecasts were evaluated at 1422 810 975 516 BIF. According to the minister, the achievements (cash) during this period were 1569 696 382 223 BIF while the expenses are 1671 521 931 834 BIF.

During the speeches, the senators expressed their concern about this budget deficit (revenues which are lower than expenditure) which is pushing the State into debt. Faced with this problem, the senators proposed to put in place strategies to improve the business climate in order to increase the tax base.

They also pointed out that the bills on budget regulations and reports arrive late in parliament. On this subject, the Minister in charge of finance suggested that the State plans to set up a unified digitization of all services to control all State revenue and expenditure, which will make it

mated at BIF 18 billion, Minister Ndihokubwayo said that this overrun comes from the investment code which gives advantages to investors for encouraging them to come and invest in Burundi on the one hand, and on the other hand, it is explained according to the minister by the activities and the material support of the development partners which are in principle always exempt, without forgetting imported medicines and fertilizers.

In his comment, the President of the Senate Right Honorable Emmanuel Sinzohagera wished that the next report be presented in time to give senators the opportunity to do a posteriori control of the execution of the State budget. n thursday, june 02, 2022, the Prime Minister of the Republic of Burundi, Alain Guillaume Bunyoni met in Rutumo in Bugarama commune in the province of Rumonge, all the stakeholders in the rehabilitation and redevelopment of the National Road nr3 on the Gitaza-Rumonge section of 45km to analyze the challenges that delayed the start of work for more than 8 months.

Acknowledging that the controversy over undiscounted compensation rates has fueled this delay and that currently this issue has been resolved by the recent ministerial order which increased compensation rates up to fourfold, all stakeholders were unanimous that work will restart on june 9,2022.

After giving the floor to all these stakeholders, it was noted that the works were blocked by the question of compensation for the property which is in the right-of -way and those of the kibozi laterite extraction site that the SOGEA SATOM company will use in the compaction of the road to carry out the works of redevelopment and rehabilitation of this roadway.

Prime Minister Alain Guillaume Bunyoni urged all the parties concerned by the granting of compensation to the population who is in the grip of the first ten km to work hard so that the minutes co-signed with the owners of the property reach SOGEA SATOM on

According to the Minister in charge of National Education, 72,313 candidates at the national level take the competition in 920 examination centers with 2,200 supervisors. The number of proofreaders is also estimated at more than 2200. On the sidelines of the supervision activities for the national competition in Karusi province, Minister François Havyarimana paid a visit to the Rusi vocational training center under construction in Shombo commune.

After the guided tour of the site of this center, the Minister of National Education and Scientific Research said that he found that the staff in charge of the constructions are working hard to complete the work as soon as possible. He said that according to

estimates, until September 2022, the work will already be completed. At the beginning of next school year, these buildings will be ready to welcome students, he added. Minister François Havyarimana explained that this vocational training center in Rusi is an important center for the country where young people can learn many trades.

The Minister in charge of National Education stressed that the students will be accommodated in this center, an added value for Karusi province, he said.

For the past ten years, Africa has been confronted with the challenges of terrorism, violent extremism and transnational crime (trafficking in human beings,

The reasoned pooling of all energies and geographically dispersed resources will bring out a new Africa "The Africa we want" as well as the identification and uncompromising recovery of the evils that plague actions and hinder the effective implementation of decisions, strategies and instruments indicated in order to provide them with the appropriate treatment.

National Round Table on Peace Education





On tuesday may 31, 2022, Ambassador Bernard NTAHIRAJA, National Coordinator of the Mechanism of the Internation-

al Conference on the Great Lakes Region (CIRGL) opened the work of the round table on "Education for Peace », in Bujumbura, King's Conference Center.

In her speech, Mrs. Flaviana Charles MAYUTTA, Director of the Gender, Women and Children Program at the ICGLR, Representative of the Executive Secretary of the ICGLR recalled that in february 2022, experts in peace education met in a training workshop, which was rich in lessons and experience sharing.

Mrs. Flaviana Charles MAYUTTA said that it is common knowledge that the Great Lakes region has been the scene of many violent conflicts in the past, both within countries and beyond borders. Therefore, these evil forces for the region require a regional approach to put an end to them. This approach is in line with the mandate and mission of the ICGLR as defined in the PACT on peace, security, stability and development in the Great Lakes region.

According to the Representative of the Executive Secretary, this round table in Burundi, which comes after that of Uganda, Rwanda and the Democratic Republic of Congo, illustrates the cooperation between countries and between the various partners involved in the promotion of peace and stability in the region. It is the culmination of the efforts of the ICGLR to promote peace and security in the Great Lakes region through the implementation by the Peace Education Project of its comprehensive re-

gional approach to peace and security. . It is also the prelude to a Joint Regional Table with the Internal Mediation Project, which is being prepared and will be held here in Bujumbura, bringing together actors from the ICGLR sub-region.

She underlined that the national round table making a training workshop for experts in peace education which took place is an important activity which comes to support the efforts of the Government of the Republic of Burundi, to establish the capacities acquired for the continuing education for peace and security in the Great Lakes Region.

Mrs. Flaviana Charles MAYUTTA added that it is necessary to find adequate responses to all sources likely to disturb peace and to make a contribution to the promotion of peace in society, in schools, during religious gatherings and to prevent conflicts and promote human rights awareness.

In his speech, Ambassador Bernard NTAHIRAJA recalled that education is the formidable weapon to change the world as Nelson MANDELA pointed out. He added that peace education is the formidable weapon to pacify the world in order to develop it. Ambassador Bernard NTAHIRAJA reminded that the Peace Education project falls under the recommendations of the ICGLR Summit on Peace Education held in 2016, as part of the implementation of the Pact on Peace, the Security, Stability and Development in the Great Lakes Region, signed in Nairobi in december 2006, which responds to the imperative of making a contribution to peace, to the gradual passage from a culture of violence to a culture of peace, with the aim of preventing violent conflicts and raising awareness of human rights in society as well as fostering cooperation between countries affected by conflict and instability.

The Peace Education Project is a regional project that is implemented in each of the four pilot countries namely Burundi, DRC, Rwanda and Uganda. The organization of this round table is planned in each of the pilot countries. It aims in particular to provide an opportunity for peace education actors from each of the four pilot countries to exchange and expand their network, to raise awareness among

stakeholders on the importance of education for peace and to strengthen the commitment of peace education actors, stakeholders and decision-makers to strengthen peace education in their countries.

In Burundi, peace education is a reality. Ambassador Bernard NTAHIRAJA hailed to this

end the activities of moralization, especially of youth, under the leadership of His Excellency Evariste NDAYISHIMIYE, President of the Republic of Burundi, which occupy a prominent place in education for peace, respect others and patriotism. The next regional round table of the four pilot countries and other partners, planned for the near future, will also be held in Burundi. (MFADC)

The United Nations Permenant Advisory Committee on Security Questions in Central Africa commemorates its 30th anniversary



rom may 23 to 25, 2022, at Amphitheater No 350 of the Institute of International Relations of

Cameroon (IRIC), created in 1971, in Yaoundé, the United Nations Standing Advisory Committee on Security Issues in Central Africa commemorated its 30th anniversary at the service of the activities of the States of the United Nations Standing Advisory Committee in charge of security issues in Central Africa. This committee was set up on may 28, 1992 by the Secretary General of the United Nations (UN), in accordance with Resolution 46/37 B adopted on december 6, 1991 by the General Assembly of the United Nations. This committee is a response to a request made on November 28, 1986 by the member countries of the Economic Community of Central African States (ECCAS), who wanted to have a tool to deal with the many conflicts with which they had been confronted since 1980.

This committee has an office commonly referred to as the United Nations Regional Office for Central Africa as its Secretariat. Previously, this mission fell to the United Nations Regional Center for Peace and Disarmament in Central

Africa (UNREC). This committee's main mission is to carry out "activities for the reconstruction and strengthening of confidence between its member states, in particular through confidence-building measures and the limitation of armaments". In 30 years of life, we recognize that the United Nations Standing Advisory Committee on Security Issues in Central Africa has achieved its objectives. Despite the reform of the Economic Community of Central African States (ECCAS), this committee remains a laboratory for the commission in the architecture of peace and security in Central Africa.

This committee has been able to implement several mechanisms and instruments in favor of peace and security in Central Africa. This specifically concerns: the Central African Convention for the control of small arms and light weapons, their ammunition, and all parts and components that can be used for their manufacture, repair and assembly approved on april 30, 2010 during the 30th UNSAC meeting held in Kinshasa, Democratic Republic of Congo; the nonaggression pact signed in Yaoundé on july 8, 1996 by the Heads of State and Government of Central Africa; the Council for Peace and Security in Central Africa (COPAX); the United Nations Center for Human Rights and Democracy in Central Africa (1999); of the Parliament of the Economic and Monetary Community of Central Africa (CEMAC), which is governed by a Convention dated june 24, 2008.

In this celebration, Burundi was represented by Mrs. Domitille NDIKURIYO, Director of the Promotion of Migrants within the Ministry of Foreign Affairs and Development Cooperation (MFACD)

MEDIA RELEASE N°10 CONSECUTIVE TO THE CABINET MEETING HELD ON WEDNESDAY 01 JUNE 2022

A Cabinet meeting was held in Gitega on Wednesday 1st of June 2022, under the chairmanship of His Excellency Major General Evariste NDAYISHIMIYE, President of the Republic of Burundi.

After the presentation of the agenda, His Excellency the President of the Republic invited the Prime Minister to present the summary of the observations resulting from the preparatory meeting of the Council of Ministers which the Prime Minister chaired on Monday 30 May 2022, and which was devoted to the analysis of the same files on the agenda.

After restitution by the Prime Minister to the President of the Republic, the following issues were analyzed:

1. Bill fixing the general State budget for the 2022-2023 Financial year, presented by the Minister of Finance, Budget and Economic Planning.

The 2022/2023 finance bill is prepared in a particular context of the implementation of public finance management reforms, aimed at migrating from the medium budget to the program budget. For the 2022/2023 financial year, the draft State budget is therefore transitional with results-based budgeting where budget allocations are made on the basis of well-planned projects/programmes/activities in order to be able to migrate completely to budgeting in "program mode" from the Fiscal Year 2023/2024.

This way of budgeting implies that the budget appropriations allocated to

activities through the Annual Work Plan and Budget constitute a capital investment that will generate interest in terms of expected results.

The 2022/2023 draft State budget, which marks the transition to the program budget, introduces the Annual Work Plan and Budget as a tool for its implementation. To do this, all the ministries and institutions, the Personalized Administrations of the State, the Public Establishments of an Administrative Nature, the Companies with Public Participation and all the municipalities of the country have prepared their budget forecasts by indicating the activities to be carried out with objectively verifiable indicators, to allow monitoring and evaluation of the expected results on a quarterly basis.

As part of the 2022/2023 budgetary transparency and traceability, the revenue that was collected by the Personalized Administrations of the State, the Public Establishments of an Administrative Nature and other public services operating on the basis of State subsidies fall into taxation managed by the Burundi Revenue Authority.

In the field of agriculture and livestock, the 2022-2023 draft budget places particular emphasis on financing the increase in agro-pastoral production through the subsidy of organo-mineral fertilizers and the production of selected seeds, the cattle herd restocking program in favor of the population grouped in agro-pastoral cooperatives.

To encourage producers, a remunerative purchase price for the production will be set to find sustainable solutions related to the problems of crop management.

In the field of economic and social infrastructure, in terms of transport, the construction of the railway linking Uvinza-Maragarazi-Musongati-Gitega has been highly privileged.

In order to finance development projects and youth employment, the Government will grant allocations to the Youth Economic Empowerment and

Employment Program and increase the capital in the Youth Investment Bank and the Impulse, Guarantee and Accompaniment Fund.

The 2022/2023 draft budget provides financial support consisting of the digitization of public services, which is a reform to modernize the collection of public revenue.

In an effort to increase revenues, significant measures are planned to ensure that the set objective is achieved. Thus, the OBR will pursue and undertake the following actions:

- Strengthening the collection of taxes on mining sector activities;
- Taking steps to reduce the informal sector through local taxation;
- Rigorous application of the law concerning dividends to be paid to the State;
- The initiation of the revision of texts and the procedure for granting exemptions;
- Acceleration of the process of recovery of arrears by the Burundi Revenue Authority;
- The collection of non-tax revenue, hitherto carried out by the administrations in violation of the law, will be carried out by the OBR;
- The improvement of revenue collection tools, namely the revised laws and the IT infrastructure;
- The strengthening of mechanisms to fight against corruption, fraud and smuggling;
- Improving mechanisms for broadening the tax base;
- Computerization of all OBR services;
- Rigorous monitoring of VAT refunds.

For this budget year 2022/2023, overall revenue increases from BIF 1,562.06 billion in 2021/2022 to BIF 2,193.6 billion in 2022/2023, an increase of 40.4%. As for expenses, they go from 1,713.8 billion BIF in the State budget, Fiscal Year 2021/2022 to 2,391.08 billion BIF in the draft State budget for Fiscal Year

2022/2023, an increase of 39.5%.

The overall deficit of the 2022/2023 General Budget project amounts to BIF

197.4 billion against BIF 151.8 billion (2.02%) in 2021/2022, an increase of 2.38%

As part of the execution of the budget for the Fiscal Year 2022/2023, a quarterly expenditure commitment plan will be prepared and implemented based on the Work Plans and Annual Budget of the ministries and institutions, and a plan rolling cash. The quarterly commitment plan will be validated by the Council of Ministers.

All budgetary expenditure must be subject to the prior authorization of the Minister in charge of Finance and executed taking into account available resources.

After discussion and debate, the project was adopted with the following recommendations:

- Specify that the payment of school and academic fees or any other transactions must be made in local currency;
- Increase the renewal costs of IT plates to 300,000 FBu;
- Project vehicles that will be transferred to the State after their closure must pay license plate fees like other vehicles;
- Accommodate all budget headings related to the construction of infrastructure at the level of the Ministry in charge of Infrastructure from the 2022/2023 budget year. The sectoral ministries are required to make forecasts of the necessary constructions and send them to the Ministry in charge of Infrastructure and ensure the joint monitoring of the execution of the projects;
- With regard to the driving license, apply the tax of 100,000 FBu, especially since the contract with the partner who was responsible for their production has been closed;
- Continue to detect investments made especially in commercial banks by state structures so that they are included in the state budget;
- Continue to broaden the tax base by identifying other sources;
- Proceed directly to the collection of taxes in mobile telephone companies;
- Adjust the budget taking into account the taxes collected in mobile telephony

to take into account the tariffs which will be applied following Burundi's accession to the single communication network of the East African Community under the "One Network Area" initiative

- Carry out the forced recovery of funds owed to the State by mobile telephone companies
- Revise the law governing income tax to broaden the category of taxpayers;
- Carefully study the system of collection and marketing of food products to fight against rising prices;

2. Note on the participation of BANCOBU in the share capital of the Burundi Stock Exchange, presented by the Minister of Finance, Budget and Economic Planning.

After the promulgation of the 2019 law governing the capital market in Burundi and the 2020 law governing the Capital Markets Regulatory Authority in Burundi, Capital Market activities are centered on the Stock Exchange. The current stage concerns the establishment and operationalization of this market, by setting up a mixed company called "Burundi Stock Exchange", whose role will be to manage the stock market, to help and control the purchase and sale of securities.

The Burundi Stock Exchange will be established as a commercial entity, registered under the Code of Private Companies with Public Participation.

On December 01, 2021, the Central Bank wrote a correspondence to BANCOBU to request its subscription to the share capital of the Burundi Stock Exchange. The same correspondence was sent to all commercial banks carrying out these activities in Burundi.

The BANCOBU Board of Directors voted for the subscription of five hundred million Burundian francs (500,000,000 Fbu) out of a total capital of 2,500,000,000 Fbu.

This note was prepared to collect the orientation of the Council of Ministers as

well as the non-objection for the continuation of the procedures.

At the end of the analysis, the Council of Ministers gave its agreement for BANCOBU to participate in the Social Capital of the Burundi Stock Exchange and to proceed to the following procedures.

3. Note on the national census of georeferenced and digitized real estate assets of the State, presented by the Minister of Finance, Budget and Economic Planning.

This note was drawn up with the aim of implementing the recommendations of government retreats relating to the proper management of State assets, as well as the Government Action Plan 2021-2022 which included, among other things, the national census of State property assets among the priority actions.

Given that the State's assets cover a very vast field (real estate assets, financial assets and movable assets including rolling stock and machinery), the Government has seen fit to start with the State's real estate assets (land and/or real estate) which occupies a very predominant part in the country's economy.

It is within this framework that the Ministry in charge of Finance, in technical collaboration with ISTEEBU, has just carried out this action.

As a result, a total of 17,545 buildings were identified. The majority of buildings are made up of schools and administrative buildings.

Data from the census show a number of 372 state buildings that are rented.

For this category of rented buildings, the finding is that:

- The list of rented buildings is not exhaustive, because some managers in charge of State assets did not want to communicate the number of employees

in these buildings and the actual amount received;

- The established rental contracts do not comply with the regulations in force;
- Rental revenue is not paid directly into the general Treasury account;
- Rented State buildings are poorly maintained with poorly maintained equipment.

This census therefore constitutes an important database that will allow:

- The easy implementation of actions related to the proper management of this State heritage;
- Automatic updating of data without resorting to another census;
- Consultation at any time and in real time of the desired data of the components of the State's real estate assets.

For good financial governance, this work should be supplemented by the identification of other categories of State assets, in particular financial assets, in order to have complete basic tools with a view to contributing to the development of the national economy. Other actions are also necessary, in particular the creation of State heritage management services in all ministries, in order to guarantee the sustainability of this work.

This census constitutes an important database which will allow the taking into account of the real estate heritage of the State in the national accounts and which will change in a significant way the index of human development of our country which is often classified among the poorest countries on the planet.

After analysis, the Council of Ministers appreciated the work carried out and made the following observations and recommendations:

- For regular monitoring of State buildings, it is necessary to update these buildings annually;
- For buildings in poor condition, it is necessary to establish responsibilities so that the State can take the necessary measures;

- All buildings belonging to the State must be valued;
- The regulations that set the rental rates for State buildings must be applied;
- The census is to be continued to have the complete situation of the State's assets.
- 4. Bill on the ratification by the Republic of Burundi of the Bilateral Agreement on the abolition of visas for the benefit of holders of diplomatic or service passports between the Government of the Republic of Burundi and the Government of the People's Democratic Republic of Algeria , signed on March 17, 2022 in Algiers,
- 5. Bill on ratification between the Government of the Republic of Turkey and the Government of the Republic of Burundi with a view to avoiding double taxation and preventing tax evasion with respect to income tax
- 6. Bill on the ratification by the Republic of Burundi of the General Cooperation Agreement between the Government of Burundi and the State of Israel.

These three projects were presented by the Minister of Foreign Affairs and Development Cooperation.

These three projects aim to intensify the ties of friendship and cooperation, to further strengthen the bilateral relations between Burundi and these three countries.

Ratification of the bilateral agreement on the abolition of visas for the benefit of holders of diplomatic or service passports between the Government of the Republic of Burundi and the Government of the People's Democratic Republic of Algeria will facilitate the movement of national populations of the parties to the agreement on the one hand and the intra-African movement of nationals of the continent on the other.

With regard to the agreement between the Government of the Republic of

Turkey and the Government of the Republic of Burundi with a view to avoiding double taxation and preventing tax evasion with respect to income tax, with the aim of promoting economic relations and above all of improving cooperation in tax matters.

This agreement constitutes an appropriate framework for economic cooperation and a basic instrument for commercial exchanges, intending to eliminate double taxation and prevent tax evasion with respect to taxes, without creating possibilities of non-taxation or reduced taxation through tax evasion or evasion.

With regard to the General Cooperation Agreement between the Government of Burundi and the Government of the State of Israel, the areas of cooperation within the framework of the said agreement are, among others, agriculture, research and development, economic and fiscal matters, trade, technical cooperation and other areas of mutual interest on which the two Parties will agree.

After discussion and debate, the three projects were adopted.

7. Information note on the "e-nama" platform integrating the interconnection of members of the Government, presented by the Minister of Communication, Information Technologies and the Media.

In order to boost the digital sector, the Government of Burundi has developed and implemented the National Policy for the Development of Information and Communication Technologies since 2011.

This policy provides for the digitization of public institutions.

This note highlights a project that aims to use information and communication technologies in the management of the process of preparing meetings of the Council of Ministers.

This project includes the development of a communication and data exchange platform between government institutions, and electronic document

management.

The objective sought is to optimize government work through the use of information and communication technologies to make these tools a powerful lever for socio-economic development.

The e-nama Platform accessible online is one of the digital solutions that the Executive Secretariat of Information and Communication Technologies offers to the Government in order to reduce all expenses related to cost and time on the one hand and improve the performance of the Council of Ministers with the "Zero Paper" Policy.

The note indicates the means necessary to achieve this objective.

After discussions and discussions, the following observations and recommendations were made:

- It is necessary to improve the performance of the local computer networks of all the ministerial cabinets, and of the General Secretariat of the State in addition to the superstructure (Presidency, Vice-Presidency and the Prime Minister);
- The funds necessary for the operationalization of the "e-nama" platform integrating the interconnection of Members of the Government will come from the Universal Service Fund.
- The Executive Secretariat for Information and Communication Technologies is to be supported in the work of digitizing government services;
- 8. Draft decree on the accession of Burundi to the single communication network of the East African Community at the "One Network Area" (ONA) initiative, presented by the Services of the Presidency of the Republic.

During the 5th Northern Corridor Heads of State Summit held in Nairobi on May 2, 2014, the Heads of State adopted several guidelines aimed at fostering deeper integration within the sub-region.

Recognizing that roaming charges are too high for trade and have an impact on regional integration and on the prices of goods and services within the subregion, the Heads of State of the East - African region have adopted concrete measures to reduce the costs of roaming for citizens, through an initiative called "One Network-Area (ONA) / Zone à Réseau Unique de communications, whose deadline for implementation was set at the end of year 2014.

As a reminder, the initiative to create a Single Communication Network Zone "ONA" within the East African Community was taken by the Heads of State of the region for two major reasons:

- Instill regional cooperation between operators, regulators and governments of the East African Community, in order to facilitate and encourage the exchange of goods and services;
- Solve the thorny problem of the high cost of roaming (communication service in roaming mode) within the Community.

During the other meetings that followed, Burundi committed to implement the East African Community roaming framework no later than June 30, 2022.

It should be noted that among the members of the East African Community, only Burundi has not yet joined this project, as well as the Democratic Republic of Congo which has just joined this Community very recently.

The interest of implementing the East African Community Roaming Framework will be important for Burundian citizens faced with the high costs of roaming in general and regional roaming in particular. By integrating the single network of the East African Community, communication will become easier and increase traffic allowing an increase in related taxes.

A draft decree is proposed that can serve as a basis for the implementation of this project in Burundi. This draft decree indicates that the regional retail rate is capped at USD 0.10 per minute including applicable taxes in each country of the East African Community, and the interoperator rate for the region is capped at USD 0.07 per minute.

After exchanges and debates, the project was adopted subject to a few formal corrections.

9. Note on the management of problems caused by the non-compliance with legal texts by certain managers of basic, post-basic and university education establishments, presented by the Minister of National Education and Scientific Research.

Fundamental, post-basic and university education establishments are governed by legal texts that those in charge must imperatively respect.

However, some of them, out of bad faith or ignorance, do not respect them and the application of the sanctions provided for in these texts works to the detriment of pupils and students. This creates conflicts either between the pupils/students and their establishments, or between the Ministry and these establishments. This note first presents the problems observed at the level of Basic and Post-Basic Education and then those observed in higher education while proposing possible solutions.

The cases observed at the level of basic and post-basic education are in particular:

- the opening of schools without authorization;
- The enrollment of students at all levels while the opening ordinance only provides for enrollment in the first years (1st kindergarten, 1st fundamental and first post-fundamental)
- Reception of students in the middle of the year without authorization.

All these three cases are frequently observed in private schools located in urban centers and especially in the City of Bujumbura.

At the level of higher education, there are irregularities in higher education institutions, particularly private ones, in relation to non-compliance with the legal framework governing higher education.

The challenges related to graduation in Higher Education Institutions are

mainly due to non-compliance with the legal framework. To this end, the following challenges should be mentioned, among others:

- Non-compliance with the conditions of access to higher education;
- Opening of training programs and Organization of lessons without a ministerial order authorizing the opening;
- Graduation without having the program accreditation order;
- Non-compliance with regulations on the organization of administrative and academic governance;
- · Insufficient financial means.

After Analysis and discussions, the following observations and recommendations were made:

- A. For fundamental and post-basic establishments, apply the following measures:
- Close, from the 2022/2023 school year, all establishments that have opened without authorization;
- Sanction establishments that have committed faults in accordance with the texts in force:
- Review the ordinance prohibiting the enrollment of students at all levels when the establishment is regular and has sufficient reception capacity;
- Identify at the level of the State services those who are last in this situation and punish them.
- B. For higher education institutions, the following measures are taken in particular:
- For graduates of technical education who were not entitled to the national test and who began their university studies after the entry into force of Law No. 1/22 of December 30, 2011 on the Reorganization of Higher Education in Burundi, their diplomas will not be recognized and will have to pass the State Examination to start university again if they want to.

- For students who do not hold a State diploma who have followed professional level programs that are not authorized or approved and have been enrolled against Decree No. 100/140 of June 6, 2013 on the organization of Professional Higher Education Medical and Paramedical in Burundi, they must be granted the diploma of Higher Technician level A1 by derogation;
- The educational institutions at various levels responsible for these irregularities must be prosecuted.

10. Any Other Business

- The Minister in charge of Infrastructure presented the progress report on the implementation of the recommendations of the Council of Ministers of May 18, 2022 in relation to the issue of execution of the contract for the sale of the land housing the former AFB stadium concluded between the State of Burundi and TOYOTA BURUNDI.

He indicated that all the elements attesting to the fraudulent maneuvers used in obtaining and transferring the title of ownership of this land have been gathered. The procedures for terminating the contract in connection with the sale of this land and its return to the heritage of the State have been initiated. The implementation of the other recommendations is also continuing.

- The Minister of Communication, Information Technologies and the Media spoke about the progress of negotiations on the Support Project for the Foundations of the Digital Economy in Burundi with the partner. She indicated that this Project will be presented to the IDA Board of Directors on June 22, 2022.

She also informed the Council of Ministers on the equipment of the Digital Broadcasting Company of Burundi which is in the stocks of Startimes. She indicated that the answer to the question of storage of material posed by the Startimes group and delivery-receipt of this material can only find its answer

with the start of the Digital Broadcasting Company of Burundi, because once the material is received, the next step would be its distribution to the beneficiaries. However, this cannot be done without the start-up of the Company. The Council of Ministers asked him to find another place to store this material while waiting for its distribution.

- The Minister of Environment, Agriculture and Livestock informed the Council of Ministers on the appearance of the Rift Valley fever epizootic in Burundi and the means necessary for the control of this disease.

He indicated that this disease is observed in the Provinces of Ngozi, Kirundo, Muyinga, Kayanza, Karusi, Cibitoke, Bujumbura and Makamba.

Since the appearance of the disease, a total of 482 cases of cattle have been reported, of which 114 heads have died.

Contagion in animals is ensured mainly by the bite of hematophagous insects (mosquito in particular), and in humans by direct contact with blood and other secretions and organs, by consumption of poorly cooked contaminated meat and raw milk, by mosquito bites or by inhaling viral particles. Necessary measures must be taken to prevent its spread.

He indicated that the urgent measures taken include: the temporary ban on the movement of susceptible animals, the closure of livestock markets and the ban on the slaughter of ruminants in the affected areas, the rigorous management of corpses of animals and individual protection measures.

A disease control action plan has been developed and the budget for its implementation is estimated at eight million six hundred ninety-seven thousand one hundred and eighty-eight US dollars (8,697,188 USD) whose activities will be extended over a period of 12 months.

- The Minister of Hydraulics, Energy and Mining presented to the Council of Ministers a Note on the terms and conditions of the Project for the exploitation of the Musongati nickel deposit and associated minerals.

The East African Region Project Group (EAR) has expressed an interest to

invest in the mining sector to exploit Musongati nickel and associated minerals.

On March 29, 2022, the Government of Burundi and the EAR Company signed the Memorandum of Understanding concerning the exploitation of the Musongati Nickel deposit and associated Minerals.

Given that the life of this Memorandum had expired, the purpose of this Note was to request the approval of the Government on the change of the expiry date of the Memorandum and the signature of a sheet of modalities to allow the transfer money as security, which was the condition in the Memorandum before the negotiation and the outcome of the agreement itself.

The Council of Ministers gave its approval.

- Finally, His Excellency the President of the Republic reminded the members of the Government to communicate to the staff of their ministries the account number on which the contributions for the construction of the Gitega Palace are paid. He also recalled that the contribution is in no way obligatory and that everyone does so according to their possibilities.
