# Adoption unanimously of the bill governing the Burundi Capital Market Regulatory Authority



arliamentarians met in plenary on Thursday, September 10, 2020 at Bujumbura to analyze and

adopt the bill governing the Burundi Capital Market Regulatory Authority.

During his explanatory memorandum, the Minister of Finance, Budget and Economic Planning Dr. Domitien Ndihokubwayo indicated that the Authority will have the status of a public establishment endowed with legal personality, with its own patrimony as well as administrative and financial autonomy. It will be placed under the supervision of the Minister having Finance in his attributions.

The Minister in charge of Finance further indicated that some of the missions of that body are, among others, the

facilitation of the creation of a market on which financial securities can be offered and traded in an orderly, fair, efficient and transparent manner; approve the issue of prospectuses; prospectuses and other distribution documents by means of which the securities are offered to the public, without prejudice to the provisions of the law governing the capital market.



There is also the taxation, the determination of the categories of persons whose approval or authorization is not required to exercise a capital market activity. But also the imposition of remedial measures and the imposition of sanctions provided for by other laws and regulations in force and many others.

After analysis and amendment, this bill was adopted unanimously by the Parliamentarians who were present

# CENI: Evaluation of the 2020 electoral process with the magistrates



he Independent National Electoral Commission (CENI) organized, an evaluation retreat of the 2020 electoral process with the magistrates, at Bujumbura, on Wednesday September 9, 2020.

In his opening speech the President of the CENI Dr. Pierre Claver Kazihise was satisfied that the elections were held in peace, without any support from the outside. For him, political parties have put forward social projects, a sign that democracy has taken root in Burundi.

"This retreat offered the magistrates who played a leading role in the previous electoral process, an op-

portunity to raise the challenges that have arisen so that the next elections will be better compared to those that have already taken place in Burundi", added the President of the Senate.

In his presentation, the CENI President Dr. Pierre Claver Kazihise explained that civic and electoral education for the 2020 elections led to satisfactory results. According to the President of the CENI, voter turnout rates increased in 2020 compared to 2015 while draws and abstentions decreased significantly.

During this retreat, the magistrates recommended continuing to raise awareness, explaining that most citizens do not know the electoral code.

These magistrates also raised the shortcomings that were observed during the previous elections, in particular the fines that were too high for electoral offenses, and asked that the electoral code be popularized to users to know what behavior to adopt during such offenses.

Magistrates, like all other civil servants, have requested the privilege of exercising their right to vote wherever they arrive during the elections, arguing that this civic duty can be missed following transfers or

other obligations.

For the elderly and the disabled, the staff of the CENI and the magistrates all agreed that these categories of people could have priority over the voting threads. And the Pesident of the CENI to underline that this instruction had been given to the

Independent Provincial Electoral Commissions (CEPI) and to the Independent Communal Electoral Commissions (CECI); and specified that those who override this measure are outlaw.

# The CENI prepares the next electoral process of 2025



The Independent National Electoral Commission (CENI) organized a meeting on Monday, September 07, 2020 for the Defense and Security corps. It was a question of making an evaluation of the electoral process of 2020 within the framework of the preparation of the elections of 2025. According to the President of the CENI Dr. Pierre Claver Kazihise, the participants mainly focused on some challenges observed on the ground even if the elections went well.

Dr. Pierre Claver Kazihise took the opportunity to thank everyone who contributed to the smooth running of these elections in general and the Defense and Security forces in particular. Among the challenges observed by the participants there are, the movement of materials used after the vote, people who committed the same offenses but who were not punished in the same way, the Defense and Security corps denied the right to vote in hill elections because the law required voters to vote where they were registered, etc.

Facing all these challenges, Dr. Pierre Claver Kazihise promised improvement. He announced that the CENI has noticed small concerns here and there, and that it will take them into account during the elections of 2025. He indicated that this meeting was organized as part of a better preparation for the next electoral process.

Participants made some recommendations, including strengthening voter education and closing voting operations before 4 p.m. to facilitate the count.

# COMMUNIQUE FROM THE GOVERNMENT OF THE REPUBLIC OF BURUNDI ON THE SITUATION OF BURUNDIAN REFUGEES IN THE MAHAMA CAMP IN RWANDA

- On July 26, 2020, three hundred and thirty-one (331) Burundian refugees in the Mahama camp in Rwanda sent a letter to His Excellency the President of the Republic of Burundi to request his involvement in their repatriation into their country of origin in dignity and lawfully within the framework of voluntary repatriation, given that the cause of their exile no longer exists.
- 2. On August 05, 2020, five (5) Burundian refugees signatories of the letter of July 26, 2020 seized the Diplomatic Mission of Burundi in Kigali, also by letter, by which they denounce the threats by Madame Marguerite BARANKITSE, founder of the NGO Maison Shalom, a refugee herself in Rwanda, and request their physical protection.
- 3. It should be recalled that the said refugees are recognized and assisted within the framework of the 1951 Convention relating to the Status of Refugees. They are therefore in the hands of the host country and the United Nations High Commissioner for Refugees who have the obligation, in accordance with International Law, to remove any artificial obstacle aimed at keeping refugees in refugee camps against their will.
- 4. The UNHCR has the role of guardian of the 1951 Convention and its 1967 Protocol and is therefore the keystone of refugee protection.
- In accordance with this legislation, member states must cooperate with UNHCR to ensure that the rights of refugees are fully respected and protected, and to prevent refugees from being held hostage for political reasons.

- 6. From the foregoing, the Government of the Republic of Burundi calls on the UNHCR and the host Government to ensure that the Burundian refugees in Rwanda who have expressed their desire to return to their country are protected as well as their families, in accordance with the spirit and the letter of the said Convention.
- The Government of the Republic of Burundi is naturally disposed to warmly and worthily welcome its daughters and sons who wish to return to their homeland.
- 8. The Government of the Republic of Burundi would like to take this opportunity to thank the UNHCR and the host countries which facilitated the voluntary return of Burundian refugees to their country and invites those who are not yet cooperating in this movement of return of refugees to do the same.
- 9. The Government of the Republic of Burundi reiterates its encouragement to those of the Burundian refugees still in exile to return to their homeland to bring a contribution to the socio-economic development of their country.
